

TERMS OF AGREEMENT

By signing this form, I (we) agree to the following: (1) I, and any guests in my party, will abide by the terms of this agreement at all times during the period of membership/day pass/program and will comply with all rules and regulations posted or otherwise communicated, (2) in case of illness or injury, The Salvation Army Kroc Center is authorized to secure emergency medical treatment at my expense, (3) The Salvation Army Kroc Center reserves the right to remove from the facility or terminate the membership/day pass privileges/program enrollment of any person who fails to comply with any posted rules and regulations or otherwise breaches the terms of this agreement, in which case that person will not be entitled to a refund of dues, (4) membership/day pass/program participant rights are not transferable, **(5) I grant permission for The Salvation Army Kroc Center to make visual recordings of all members and guests on Kroc Center property for its responsible use**, and (6) The Salvation Army reserves the right to change membership/day pass/program pricing with one month's notice.

LIABILITY WAIVER - I understand that use of the facilities and equipment at The Salvation Army Kroc Center may involve risk of bodily injury or property damage and I agree to assume any such risks. I understand that it is up to me to consult physicians and other professionals to make sure that I can safely participate in activities and events at The Salvation Army Kroc Center. I also understand and agree that by signing this agreement, I am giving up my (or the minor for whom I sign) right to make any claim against The Salvation Army, its agents, employees and volunteers, including the right to sue them, for bodily injury or property damage or any other loss that I might suffer while using The Salvation Army Kroc Center facilities and services, except as limited by law.

COMMUNICATIONS - By including my email and/or wireless phone number on this application, I am opting in to receive email, text, and SMS messages from the Kroc Center. I understand that I may unsubscribe at any time by following instructions in the message or making a request in writing. The Kroc Center does not share personal information with outside persons/organizations.

CLEANING - Renters are responsible for removing trash from the rental area after use. Failure to do so will result in a \$100 cleaning fee.

PHOTO RELEASE - I hereby give permission for me or my child to be photographed/videotaped with the possibility of being used in Salvation Army publicity and I give exclusive right to these photos/videos to The Salvation Army and waive all claims of compensation for usage.

NOTICE - In order to promote a safe and secure environment, The Salvation Army Kroc Center has placed video cameras in various locations, and a photo of each person entering the Kroc Center is required. If The Salvation Army has actual knowledge that an individual is a registered sex offender, such individual shall be denied access to the The Salvation Army Kroc Center. By signing this document, I represent to The Salvation Army, that neither I, nor any of my guests, are to my knowledge registered sex offenders in any legal jurisdiction and that furthermore, I have an affirmative duty to The Salvation Army to immediately disclose any change in my knowledge of the registered sex offender status for myself or any of my guests who may seek admittance to the Kroc Center pursuant to this agreement.

HOLD HARMLESS & INDEMNIFICATION AGREEMENT

In consideration of the privilege of using The Salvation Army's property at 2500 South Division Avenue, Grand Rapids, MI 49507 by (name of organization) _____, we agree to assume the risk for any injuries, including death, that may be sustained by members of our organization or any person invited as part of our group in connection with the use of said premises.

Further, we agree to indemnify, hold harmless, assume liability for and defend The Salvation Army, its trustees, officers, members and agents from all costs and expenses including, but not limited to, attorney's fees, reasonable investigative and discovery costs, court costs and any other sums which The Salvation Army, its trustees, officers, members and agents may pay or become obligated to pay for injury, including death, to persons or damage to property resulting from our use of said premises or from our actions or omissions and arising from any cause, including vehicles, except for matters caused by the negligence or willful misconduct of The Salvation Army or its trustees, officers, members and agents while acting within the scope of duties of such relationship to The Salvation Army.

Recreation Rental Guidelines



GENERAL INFORMATION & GUIDELINES

Private rental of Kroc Center recreation areas requires a paid advance reservation, and is based on availability and field conditions

Rental requests are not guaranteed, and may be denied for any reason at the discretion of the Kroc Center.

Rental reservations will not be confirmed without all of the following:

- Recreation Rental Agreement form (approved by the Kroc Center);
- Hold Harmless form;
- Full payment of the appropriate rental fees;
- Proof of liability insurance.

Recreation spaces may be reserved each year starting January 1; reservations may only be made for the current calendar year.

The Kroc Center is an alcohol-free, tobacco-free, and vaping-free campus. This includes all field space, parking lots, walkways, etc.

The Kroc Center is a Christian facility; foul language or messages on clothing, etc. will not be tolerated.

The Kroc Center holds the right to add facility supervision (parking attendant, for example) as it sees fit, at a fee of \$50 per hour, per attendant.

Renter agrees to stay within their rented space during their scheduled time, and to leave the area in the same condition as they found it.

Please call 616.588.7200 and ask for the facility supervisor if issues arise during the reservation.

GUIDELINES FOR INDOOR RECREATION AREAS

Gymnasium: Hanging from the rims, nets and/or supports is not allowed.

Climbing Wall: Bring athletic shoes or climbing shoes. No climbers in sandals or bare feet.

Aquatics Center: You must be at least 48" tall to ride the giant waterslide.

Children aged 6 and under must have an adult within arm's reach in the water at all times. Children aged 7-11 must be accompanied in the water by an adult. If the child passes a swim test, they may be supervised from the pool deck.

Children under the age of 12 are not allowed in the hot tub.

GUIDELINES FOR OUTDOOR RECREATION AREAS

The Kroc Center campus is open from dawn to 9 PM unless special permission has been granted by the Kroc Center.

All animals must be on a leash no longer than eight feet (per city ordinance) and under control at all times. Owners must pick up after their pets immediately. Pets are not allowed on athletic fields during sporting events. Pets behaving dangerously toward other guests or animals will be asked to leave.

Public restrooms are available next to the outdoor concession stand.

Hitting golf balls on the Kroc Center campus is prohibited.

Roller skates, scooters, inline skates, skateboards or bicycles are permitted on the property, but may not be used on equipment or furnishings (including railings, stairs, curbs, benches, walls, bike racks and trash cans).

Outdoor rentals will continue in the event of rain. If thunder or lightning is present, areas will remain closed until it has been 30 minutes since the most recent thunder or lightning.

Motorized vehicles are required to stay in designated parking areas. The east parking lot is recommended for most outdoor field rentals. Busses may drop off and pick up near the fields, but should park along Alger Street to preserve parking for spectators.

Giant Slip & Slide: Guests may ride on tubes or on their bottoms, feet first. Tubes provided by the Kroc Center are to be passed up the line and given to those waiting at the front of the line.

FOOD & BEVERAGES

Food is allowed only in designated areas of the building, and is prohibited in the gymnasium and aquatics center.

Personal food and beverages may be consumed on the outdoor campus; however, personal cooking devices such as grills (regardless of fuel/power source) are not permitted.

The sale of any food or beverage for rental events must be pre-approved by the Kroc Center, and will be subject to an additional fee.

SIGNAGE & DECORATIONS

Groups may not place signage on Kroc Center property without prior approval. When approved, signage should be used only on the day of the event to direct guests and provide information. Advance placement of signage to promote future events is not permitted.

ADDITIONAL EQUIPMENT & DELIVERIES

Groups are responsible for their own equipment. The Kroc Center will provide soccer goals and nets, soccer lines, volleyball posts and net as part of the rental. Groups planning to have additional equipment, such as dunk tanks, tents, chairs, tables and inflatables must receive permission from the Kroc Center before the scheduled event. All equipment is to be removed from the space immediately after the event.

CANCELLATIONS

The cancellation of a reservation must be made in writing at least 10 days in advance and will incur a 25% administrative charge if a refund is requested. Refunds are made in the form of a check or credit card charge back. Cancellation requests made less than 10 days prior to rental date are not eligible for refund. The Kroc Center reserves the right to cancel a rental and issue a refund if the fields are deemed unusable due to weather conditions.

RESCHEDULING / CHANGES / ADDITIONS

Requests to reschedule a reservation may be made only once and must be submitted in writing at least 10 days prior to the original reservation date. Rescheduled reservations are nonrefundable.

Changes or additions to existing rental reservations made more than 10 days after the original invoice is created will be subject to an additional booking fee. Changes requested less than 10 days before the original rental start date are not guaranteed.

CLEAN-UP

Groups reserving recreational space are responsible for placing their trash in the receptacles provided on campus. Failure to do so will result in additional charges. In addition, property damage or defacement of the Kroc Center as a result of use of the space will result in additional charges.

LIABILITY

1. Organizations are required to provide proof of liability insurance naming The Salvation Army Ray and Joan Kroc Corps Community Center as "Additional Insured" for the event. Proof of liability insurance with liability limits of at least \$2,000,000 combined single limit for bodily injury and property damage is due no later than the day before the scheduled rental.
2. Renter will be responsible for theft and damage to the Kroc Center premises and its property as a result of the event.
3. The Kroc Center shall have no liability of any sort with respect to the property brought onto the premises by or at the direction of the Renter or the Renters guests. All risk of loss with respect to any property shall remain with the Renter. Renters are responsible for the proper conduct of their guests.
4. The Renter will not hold the Kroc Center or any of its employees responsible for the failure to execute an event due to occurrences beyond their control, such as, but not limited to, acts of God, public emergencies or threats to the community.
5. The Kroc Center is not responsible for any injury, or illness from exposure to contagion sustained on the property.
6. The Kroc Center reserves the right to exclude or terminate any group or individual deemed to be inimical to, or is at risk to, the Kroc Center, its property, interests and mission.

OUTDOOR SPACES AVAILABLE APRIL 1 – OCTOBER 31 (WEATHER PERMITTING)

- The East and West Soccer Fields are 100 yards x 63.3 yards in size, and both meet NFHS standards for Soccer play.
- Each Youth Soccer Field is 20 x 30 yards in size, appropriate for 4v4 games in the 6U through 8U age groups.
- There are two courts that make up the outdoor basketball facility (84' x 47.5' each) and a total of six basketball hoops. Free throw and three-point lines exist.
